In April 2013 these exemptions were replaced with a new flexible discount which applied to all empty properties. Local authorities are now entitled to apply any level of discount from 0% to 100% to all empty properties.

#### Definitions for data for Broxtowe, Gedling, Nottingham City and Rushcliffe

All crime: The overall number of crimes reported to Nottinghamshire Police (for Broxtowe, Gedling, Nottingham City and Rushcliffe).

Burglary of a dwelling: Burglary is the theft, or attempted theft, from premises where access is not authorised. Damage to a premises that appears to have been caused by a person attempting to enter to commit a burglary, is also counted as burglary.

Residential and commercial burglaries are distinguished by the function of the building.

Criminal damage: Where property is intentionally destroyed or damaged, not necessarily to gain entry to premises or a vehicle.

Robbery: Theft with the use of force or a threat of force. Both personal and commercial robbery are included. Snatch theft is not included.

Violence against the person: Includes a range of offences from minor offences such as harassment and common assault, to serious offences such as murder, actual bodily harm and grievous bodily harm.

#### Definitions for data for Erewash

Violent crime: Violent crime covers a range of offence types from minor assaults, such as pushing and shoving that result in no physical harm, to murder. This includes offences where the victim was intentionally stabbed, punched, kicked, pushed or jostled, as well as offences where the victim was threatened with violence whether or not there is any injury.

Domestic Burglary: The CSEW covers domestic burglary only, which is an unauthorised entry into the victim's dwelling or non-connected building to a dwelling, but does not necessarily involve forced entry; it may be through an open window or by entering the property under false pretences (for example, impersonating an official).

Robbery: A robbery is an incident or offence in which force, or the threat of force, is used either during or immediately prior to a theft or attempted theft. As with "violence against the person", police recorded robberies cover a wide range of seriousness, from armed bank robberies to muggings for mobile phones or small amounts of money. Recorded crime offences also distinguish between robbery of personal property ("personal robbery") and business property ("business robbery"). Robbery of business property is a recorded crime classification where goods stolen belong to a business or other corporate body (such as a bank or a shop), regardless of the location of the robbery. The taking of vehicles during robberies (often termed car-jacking) is also included as robbery.

Criminal Damage and Arson: In the Crime Survey for England and Wales (CSEW), criminal damage is defined as the intentional and malicious damage to the home, other property or vehicles.
