I have also attached my original objection to this planning application that I would like the Planning Inspector to reconsider the points I have made that are not referred to in the Core Strategy document provided by Erewash. The safety of a vehicular junction which would be in a dip of a very fast road, the safety of pedestrians along a pavement that is regularly under flood water in this current time of climate change and crossing a high speed road to access the bus halt on the east side of the A6096, haven't been given sufficient consideration in the policy in my opinion. The statement of impact of the development on Spondon Wood and wildlife in the surrounding area in the Strategic Policy has not taken into account that access is already blocked on 3 sides by amenities and farms. The proposed development that Erewash is planning to impose has no positives only negatives for the residents of Spondon by trying to 'extend it's community', it has not taken into account planning already submitted to Derby City council for developments within the village boundary and is only increasing urban sprawl into GREEN BELT land.
