# Notes to accompany application forms for the grant of a Private Hire Vehicle Operator's Licence

- 1.1 By virtue of Section 46(1)(d) of the Local Government (Miscellaneous Provisions) Act 1976 no person shall, in a controlled district, operate any vehicle as a Private Hire Vehicle without having a current licence under Section 55 of the said Act (a Private Hire Vehicle Operator's Licence).
- 1.2 For the purposes of the Act, the following definitions apply:-

"private hire vehicle" means a motor vehicle constructed or adapted to seat fewer

than 9 passengers, other than a Hackney Carriage or Public Service Vehicle, which is provided for hire with the services of a driver for the purpose of carrying pas-

sengers.

"operate" means in the course of business to make provision for the invi-

tation or acceptance of bookings for a Private Hire Ve-

hicle.

"controlled district" means the Borough of Erewash.

- 2. In considering any application, the Council will wish to take into account the suitability of the premises from which you intend to operate, and the impact which your intending use may have on the local environment particularly for occupiers of neighbouring properties. For this reason you are required to state on the application form whether you intend to make provision at the premises for the reception of members of the public and also to say whether planning consent has been granted for the use of the premises in connection with a private hire business. Whilst the licensing and planning processes in relation to taxi and private hire operators are quite separate and raise different issues, it is important that you ensure that any necessary planning consent is obtained for the use of your premises for the operation of a private hire operator's business. If no such consent has been obtained, you should contact the Council's Planning Section at the Town Hall, Long Eaton (Tel No. 0115 9072244) to discuss the planning position. The Licensing Section will in any event be notifying them that you are making this application.
- 3. If a Licence is granted to you, this will be subject to conditions. Copies of these conditions may be obtained, free of charge, from the Licensing Section, The Civic Centre, Derby Road, Long Eaton, Nottingham NG10 1HU (tel: 0115 907 1113).
