I confirm that Ockbrook & Borrowash Parish Council is the relevant body to undertake neighbourhood planning in the area in accordance with S61G of the 1990 Act and Section 5C of the 2012 Regulations.

7. Intention of the Neighbourhood Plan area:

The Parish Council intends to undertake a Neighbourhood Development Plan.

- 8. Explanation / Justification of choice of area
 The area selected is the Ockbrook & Borrowash Parish Local Government Area.
- There are a number of administrative and operational benefits to the area specifically conforming with the administrative and electoral area boundaries of the parish, as well as incorporating planning issues relating to the area.
- The parish area includes 3 electoral wards: Borrowash West Parish Ward, Borrowash East Parish Ward, Ockbrook Parish Ward.

- Ockbrook & Borrowash Parish Council has been in existence for many years and is recognised by residents as the established centre for local administrative issues and planning matters, so it will be easier for parishioners to understand and identify with the process.
- Ockbrook & Borrowash Parish Council can readily take the lead with its contribution in terms of finance and knowledge in dealing with local matters, which serve the whole of the designated area
- Any subsequent financial benefit, such as additional Community Infrastructure Levy, will be available to the whole parish.
- The area conforms with the boundaries for many of the available local statistics and the ongoing local planning process.
- Regular communication with residents is provided by the Parish Council's website that is regularly updated and residents benefits from a quarterly newsletter, which is available online, in the public library, on Parish Notice Boards and hard copies from the Parish Clerk upon request. Social media can also be used for important announcements and direct contact with the community.
- The Parish Council is responsive to the needs of adjacent neighbouring communities, particularly where proposals might have a particular impact on their communities. Communication between Parish Councils will be considered important.
- Ockbrook & Borrowash Parish is situated in close proximity to the Derwent River on the southern side of Borrowash with the A52 link road between Nottingham and Derby separating Ockbrook from Borrowash and the Spondon/Ilkeston Road on the northern border of Ockbrook. The western side of the Parish is next to Spondon, Derby. Ockbrook & Borrowash Parish eastern side is next to Dale Abbey.
- Although Ockbrook & Borrowash has parish status, it has a large population of 7,171 residents (Census 2021) and attracts business and housing to the local area. Historically, Ockbrook is known as a rural farming village. It is also known for its two churches: Ockbrook Moravian Church and All Saints Church. Both churches are listed buildings, and Ockbrook Moravian Church is located on The Settlement which is 250+ years old and has the old Ockbrook School within its settlement boundaries. Most of its buildings on the old School grounds are listed or have historical value.
- The Parish of Ockbrook and Borrowash has a long history of residents wishing to contribute to local discussions and to shape the life of the community and its future. Recent discussions have identified a need for the Parish Council to produce a Neighbourhood Development Plan to give residents 'a voice' at local level.

9. Extent of the area

Ockbrook & Borrowash parish boundary has been adopted as the proposed Ockbrook & Borrowash Neighbourhood Development Plan area boundary.
