The map shown is incorrect. It fails to show both the Lime Tree Court Estate, constructed over six years ago, and the Durose Country Park Estate which the site is proposed to be bolted-on to. For what possible reason could BOTH of these sites, one of which provides the sole proposed entrance into the proposed development, could they have been missed off?

Additionally, the A-Road is the A608, not the A609 as the documents state.

Detail

And Hungerhill is a Close, not a Crescent, How could this have been incorrectly stated in the documents? Or was this a deliberate attempt to made the road appear to be something it is not?

Finally, we see the acknowledgement that this is an expansion of the existing urban area as a clear acceptance that this is a bolt-on to the city, and another bolt-on to the Oakwood Ward, which will take Derby's housing growth and urban expansion and do nothing for Erewash residents, but will count towards EBC housing figures solely due to the land it is located on.
